However, these foundations do provide grants to associated 501(c)3 nonprofit corporations. This affiliated foundation would allow access to grants from those, and other, major foundations.

After incorporation, the foundation directors will meet to select officers, approve the Foundation Bylaws, and the Conflict of Interest Policy. Following this the IRS form 1023 will be submitted, seeking tax-exempt status.

The filing fee for Texas Form 501 is \$40.00; the filing fee for Texas Form 202 is \$25.00; the filing fee for IRS Form 1023 is \$850.00. Total fee cost is \$915.00 which will be funded from unrestricted local funds.

Texoma Regional Risk Methodology

Texoma COG uses a risk based Methodology for the distribution of Homeland Security funds. The risk is calculated using a formula developed in cooperation with local Emergency Management Coordinators (EMCs). This methodology used an all hazard approach, including terrorism, to identify features that have an increase vulnerability to emergency events. The methodology was then adopted by the HSAC and the Texoma COG governing board. The method calculates the risk for seven signature jurisdictions which are the three counties, (Cooke, Fannin, & Grayson), the county seats, (Gainesville, Bonham, and Sherman), and then any other incorporated area with a population of 20,000 or greater (Denison). Homeland Security projects are sought and administered for the rest of the incorporated and unincorporated areas by the three county Emergency Management Coordinators.

The Methodology uses the following reasoning for determining risk for the seven signature jurisdictions within the region and included:

1. # of Incorporated Communities with a population greater than 350

These areas have a higher concentration of people and have shared public utilities.

2. Population over 30,000 (weighted +5)

These areas have a higher concentration of people and have an influx from outer area. Entities with a population over 30,000 have shared public utilities, increase critical infrastructure, large gathering facilities such as churches and shopping center, and regional medical amenities. Because of the number of the extra risks this category is weighted at +5.

3. # of Major Transportation Routes

Major transportation routes or transit corridors increases the risk of HAZ MAT incidents and other health and security risk such as terrorism, drugs, human trafficking, etc.

4. Federal Courthouse (weighted +3)

The location of a Federal Courthouse places the surrounding area in an increased risk of retaliation assaults, protests, gang violence, etc.

5. School Systems

Schools are high special needs population contained in a very small area. The occurrence of gang related activity increases with the size of the school system.

6. Large School Systems (weighted +3)

Larger school systems have a higher population and increased threat of gang activity.

7. X Large School Systems (weighted +5)

X Large schools have the same threats as smaller schools but also become a possible target for terrorism activity.

8. Colleges (weighted +5)

College campus have many of the same threats as school but are often larger with a more diverse culture resulting in language barriers.

These eight threats are totaled and the percentage of the threats in each area is calculated. When funding allocation amounts are released to the Texoma COG the EMC's gather and using the percentages of threat and risk, they develop projects based on their entities needs and capabilities and gaps that need to be addressed. Together the group determines projects that best meet the needs of the entities and the region as a whole. This can result in a diversion from an exact calculated amount but also gives the opportunity for entities to share assets and develop regional projects. These results are discussed and reviewed by the HSAC and a recommendation is made to the TCOG Governing Body for approval.

RECOMMENDATION

Accept grant funding in the amount of \$83,403 from the Texoma Senior Citizen Foundation for the purpose of providing services for seniors in the Sherman area through TCOG's Elder Watch Program.

BACKGROUND

The Area Agency on Aging (AAA) Elder Watch Program is a coordinated, community-based home care program administered by case managers who assist elderly citizens in Cooke, Grayson and Fannin Counties so they can maintain their dignity and personal independence. Services are available to persons 60+ years of age who are hearing and vision impaired, homebound, unable to care for themselves, and/or recently discharged from area hospitals who require temporary in-home care. The Elder Watch mission is to provide care coordination for the elderly to connect them to the proper service systems that can provide them with resources, services, benefits; and to advocate for humane and effective operation of those systems.

DISCUSSION

The Byrd Fielder Livengood Charitable Trust Cash Grants Program awarded \$83,403 to the Texoma Senior Citizen Foundation (TSCF) earmarked for TCOG's AAA Elder Watch Program. Grant funding from the Livengood Foundation will support the following immediate needs within the AAA Elder Watch program in the Sherman area: *Dental Services, Medical Reimbursement, Eye Glasses and Hearing Aids.*

BUDGET

100% of this grant will go towards direct services for seniors in the Sherman area.



RECOMMENDATION

Authorize adopting Social Media General Policy and Social Media Use Policy for Authorized Staff

BACKGROUND

TCOG management recognizes the growing importance and communications power of social media in our society. In order to use social media in a positive, constructive manner, we have developed two policies that describe and define the parameters under which TCOG staff members may access social media as an aid to fulfilling their job assignments.

DISCUSSION

Drafts of the Social Media General Policy and Social Media Use Policy for Authorized staff were made available to staff for a 30 day review and comment period. After considering and incorporating staff comments, where appropriate, a final draft was submitted for review by outside legal counsel. Legal counsel made several editorial comments, but did not substantially change the content and language in the draft documents. Copies of the final policies are attached for review and approval by the Governing Board.

SOCIAL MEDIA USE POLICY

Audience

This document outlines policy for TCOG employees, contractors, vendors and agents regarding the use of social media in order to further the goals and objectives of Texoma Council of Governments and its departments and programs where appropriate.

Acceptable Use

Unless expressly designated, trained, and/or authorized by TCOG Executive Management Team, staff members are not permitted to make posts, entries or participate in other forms of communication on social media sites to speak on behalf of TCOG in an official capacity. Social media sites shall include, but are not limited to, Facebook, Google+, LinkedIn, MySpace, Pinterest, Twitter, Tumblr, YouTube, and other online collaboration, sharing or publishing platforms, whether accessed through the web, a mobile device, text messaging, email or any other existing or emerging communications platforms through which users join online communities to share information, ideas, personal messages, and other content.

Staff members are expected to exercise personal responsibility for all online activity, which includes not violating the trust of those with whom they engage on Social Media Sites. Staff members should never use social media for covert advocacy, marketing or public relations, or any other reason which would violate policies set forth in TCOG's Personnel Policy Manual. While TCOG does encourage the personal use of and participation in Social Media, staff members not otherwise designated as official TCOG representatives who use social media to communicate about Texoma Council of Governments should clearly identify themselves as employees, and where possible include a disclaimer acknowledging that their personal opinion does not necessarily reflect the opinion of TCOG. References to official TCOG posts, located on TCOG's website, are highly encouraged.

Once a post regarding TCOG has been made it may live online indefinitely, and as such, future posts through the same account will be associated with TCOG. Unprofessional, defamatory, or otherwise derogatory posts by individuals can and will have a negative impact upon the organization.

Harassment, threats, intimidation, ethnic slurs, personal insults, obscenity, racial or religious intolerance and any other form of behavior prohibited in the workspace is also strictly prohibited via Social Media Sites. Derogatory, inflammatory, or otherwise negative comments regarding TCOG, its staff, clients, board members, or other affiliates are not acceptable, and if found to be defamatory may result in termination of employment. The prohibitions in this paragraph are not meant to and do not restrict persons subject to this policy from exercising their recognized First Amendment right to freedom of speech.

Staff members are responsible for making sure that their online activities do not interfere with their ability to fulfill their job requirements and their commitments to their managers, co-workers or clients.

Penalties

Failure to comply with this social media use policy may result in withdrawal, without notice, of access to information and/or information resources and may be grounds for disciplinary action, up to and including termination, as well as civil or criminal penalties as provided by law.

SOCIAL MEDIA USE POLICY FOR AUTHORIZED STAFF

Section 1 - Audience

This document provides guidance for authorized TCOG employees, contractors, vendors and agents for the use of social media in order to further the goals and objectives of Texoma Council of Governments and its departments and programs where appropriate.

Section 2 - Objectives

1. Establish practical, reasonable and enforceable guidelines by which authorized TCOG staff members can conduct responsible, constructive social media engagement while maintaining the reputation and integrity of the TCOG brand.
2. Promote a safe environment for staff members to share subject matter expertise that is not proprietary or confidential in nature.

Section 3 - Definitions

1. *Social Media Sites* – Social Media Sites are blogs, microblogs (i.e. Twitter), social networks, and other online collaboration, sharing or publishing platforms, whether accessed through the web, a mobile device, text messaging, email or any other existing or emerging communications platform through which users join online communities to share information, ideas, personal messages, and other content. Facebook, Twitter, LinkedIn, Pinterest, YouTube, Google+ and MySpace are all examples of popular Social Media Sites.
2. *Social Media Account* – Social Media Accounts are established for users to provide them with a personalized presence inside a Social Media Site. YouTube, Twitter, Facebook and other Social Media Sites allow users to sign-up for their own Social Media Account, which they can use to collaborate, interact and share content and status updates. When a user communicates through a Social Media Account, their posts are attributed to their User Profile.
3. *User Profile* – A User Profile is created within a Social Media Account and is customized with specific information about the user which can be made available to other users and often is a digital representation of the user's identity.
4. *Social Media Posts* – Blog posts, blog comments, articles, links to web pages, status updates, text messages, posts via email, images, audio recordings, video recordings or any other information made available through a Social Media Site. Social Media Posts are the actual communications a user distributes through a Social Media Site, usually by means of their Social Media Account.
5. *Facebook Page* – Pages allow businesses, brands, and celebrities to connect with people on Facebook. Admins can share information and news feed updates to people who *like* their pages.
6. *News Feed* – A News Feed is the ongoing list of updates on the home page of a Facebook Social Media Account that shows what's new with the friends and pages that are followed.
7. *Tweets and Retweets* – A Tweet is a 140 character Social Media Post distributed on the Twitter microblogging service. Information is propagated on Twitter through Retweets, where one user shares or forwards the Tweets of another Twitter user.

SOCIAL MEDIA USE POLICY FOR AUTHORIZED STAFF

8. *Hashtag* – A hashtag, denoted by the # sign in front of a keyword, is used to highlight specific keywords in a tweet that can then be used as search terms throughout Twitter.
9. *Copyrights* – Copyrights protect the right of copyright owners to control the reproduction and use of any creative expression that has been fixed in tangible form, such as literary works, graphical works, photographic works, audiovisual works, electronic works and musical works. The reproduction, forwarding, or in any other way republishing or redistribution of words, graphics, or other copyrighted materials must be done only with the permission of the copyright owner.
10. *Hosted Content* – Text, pictures, audio, video or other information in digital form that is uploaded and resides in the Social Media Account of a user. If you download content from the Internet, and then upload it to your Social Media Account, you are hosting that content. This distinction is important because it is generally illegal to host copyrighted content publicly on the Internet without first obtaining the permission of the copyright owner.
11. *Embed Codes* – Unique codes that are provided to allow others to share online content without requiring the sharer to host that content. By means of an embed code, it is possible to display a YouTube user's video in someone else's Social Media Account without requiring that person to host the source video file. This distinction is important because embed codes are often used by copyright owners to encourage others to share their content via Social Media Sites.
12. *Controversial Issues* – Issues that form the basis of heated debate, often identified in political campaigns as wedge issues, since they provoke a strong emotional response. Examples include political views, health care reform, gun control and abortion. Religious beliefs may also be controversial, particularly to those intolerant of beliefs different from their own.
13. *Official Content* – Publicly available online content created and made public by Texoma Council of Governments, verified by virtue of the fact that it is accessible through TCOG's official website.
14. *Inbound Links* – A hyperlink that transits from another website to TCOG's website is referred to as an inbound link. Inbound links are important because they play a role in how search engines rank pages and domains in search results.

SOCIAL MEDIA USE POLICY FOR AUTHORIZED STAFF

Section 4 –Acceptable Use and Administration

The best and most acceptable use of social media tools will generally fall into two categories:

- 1) As sites for disseminating time-sensitive information as quickly as possible
- 2) As marketing/promotional sites which increase TCOG's ability to broadcast its messages to the widest possible audience.

All TCOG-related Social Media Sites and social media tools proposed for TCOG use will be subject to the approval of the Executive Management Team. TCOG's website (www.tcog.com) will remain the organization's primary and predominant presence on the Internet. Wherever possible, content posted to TCOG's Social Media Sites should also be available on TCOG's website and should contain links encouraging users or otherwise directing users back to TCOG's official website for in-depth information, forms, documents, or online services necessary to providing services to the region. Articles and press releases should be posted through Social Media Accounts by simply posting the title of the article or press release with a link to the full article on TCOG's website.

All TCOG Social Media Sites shall comply with all appropriate TCOG policies, including but not limited to:

- 1) Employee Responsibilities;
- 2) Computing, Communication & Internet Policies; and
- 3) Information Resources Use Policy.

Social Media Posts on TCOG Social Media Sites may not contain any of the following forms of content:

- 1) Content that promotes, fosters, or perpetuates discrimination on the basis of race, color, religion, sex, national origin, age, disability, marital status, genetic information, political affiliation or belief, or any other protected status.
- 2) Profane or obscene language or content;
- 3) Sexual content or links to sexual content;
- 4) Comments in support of or opposition to political campaigns or ballot measures;
- 5) Solicitations of commerce;
- 6) Conduct or encouragement of illegal activity, including copyright infringement, obscenity, libel, slander, fraud, defamation, plagiarism, harassment, political activism, intimidation, forgery, impersonation, soliciting for illegal pyramid schemes, and computer tampering;
- 7) Information that may tend to compromise the safety or security of the public; or
- 8) Confidential information including the identity or disclosure of personally-identifiable information of directors, officers, employees, clients, or vendors of TCOG as prohibited by law.

TCOG reserves the right to restrict or remove any content including audience comment that is deemed in violation of this Social Media Use Policy or any applicable law.

Administration of TCOG Social Media Sites

- 1) A list of Social Media Sites which are approved for use shall be maintained on the Intranet with direct links to the TCOG or TCOG-related Social Media Account.

- 2) When applicable, customize the URL to the profile page in a consistent and recognizable manner that reflects the organization's name. For example, Texoma Council of Governments' primary Twitter URL is Twitter.com/TexomaCOG
- 3) No new Social Media Accounts or administrative changes to existing Social Media Accounts may be created or made unless first approved or authorized by a Department Director. A list of login and password information will be maintained on the Intranet.
- 4) The email address associated with each Social Media Account shall be an official TCOG-supplied email address. The use of personal or non-TCOG email accounts and addresses for TCOG Social Media Account administration is prohibited, as is the use of a TCOG-supplied email account or password in conjunction with a personal Social Media Account.

All posts and information shared on TCOG or TCOG-related Social Media Sites are subject to public information laws. Content maintained in a social media format that is related to TCOG business, including a list of subscribers and posted communication, is public information unless expressly exempted by law. However, communications requesting public information that are made through e-mail and messaging systems within Social Media Sites will not be considered public information requests until sent through the proper channels.

Section 5 – Identity and Behavior

Social Media Sites differ in what are considered proper and improper business uses. For example, members of Social Media Sites are expected to read, and when appropriate respond to, questions asked of them from other members of their social network. You should understand what is recommended, expected and required when you discuss TCOG or TCOG-related topics, whether at work or on your own time.

5.1 Identity

Since reputations are built on trust, you are strongly encouraged to disclose your identity and affiliation to TCOG whenever discussing TCOG or TCOG-related topics via Social Media Sites.

1. Be aware of your relationship to our organization in all Social Media Posts. Nothing gains more notice in Social Media Sites than honesty – or dishonesty. If you have a vested interest in something you are discussing, be the first to acknowledge that relationship and point it out.
2. Comply with all laws and regulations regarding disclosure of your identity.
3. TCOG believes in transparency and honesty. You are encouraged to use your real name and identify that you work for TCOG in any Social Media Post that involves TCOG or TCOG-related topics.
4. Misrepresenting, obscuring, suppressing, or replacing a user's identity on the Internet is misleading. You should never represent yourself to be anyone other than who you really are.
5. Be consistent on all profile pages of your Social Media Accounts. Conflicting information damages your credibility, and could also adversely impact TCOG's reputation. New staff members who intend to use social media to discuss our organization or organization-related topics are encouraged to update their User Profiles to reflect these guidelines.
6. Contractors, interns and vendors are prohibited from representing themselves as TCOG employees.

SOCIAL MEDIA USE POLICY FOR AUTHORIZED STAFF

5.2 Behavior

Be direct, informative and brief when creating and managing posts on Social Media Sites. Before posting, you should spell- and grammar-check all content to ensure any mistakes are corrected.

Please be sensitive when providing links in Social Media Posts to external content. Redirecting to another site may imply an endorsement by TCOG of its content.

5.2.1 Commenting

Whenever commenting on TCOG or TCOG-related topics via Social Media Sites, you are requested to:

1. Use a method of posting that makes it easy for the average reader to understand your position, avoid jargon or ambiguous language, and always provide a functional means by which you can be contacted in a timely manner based on the nature of your Social Media Post. Misinformation has the potential to spread quickly online and it is our intention to limit the use of technical or ambiguous language that could be misinterpreted by others. The failure to reply to legitimate questions which arise from comments and posts made by staff members in Social Media Sites, particularly by staff members who initiated a conversation, could also result in a negative impression of TCOG or our services. Staff members who engage in Social Media Sites about TCOG or TCOG-related topics are required to monitor their feedback and use their best judgment to respond appropriately when warranted.
2. You should only mention TCOG's official policies in your Social Media Posts when those policies are publicly available on the Internet, and shall only do so if you include a link to that policy in your post.
3. If you choose to share an opinion on official TCOG policy, you may do so only if you precede your Social Media Post with a disclaimer acknowledging that your personal opinion does not necessarily reflect the opinion of TCOG (i.e. The post on this site is my own and doesn't necessarily reflect or represent the opinions of Texoma Council of Governments or the department for which I work). This requirement is meant to ensure that others can easily distinguish the official position of TCOG or TCOG's management from yours.
4. You are encouraged to use sentence-case format with posts and comments in all Social Media Sites and elsewhere on the Internet and should avoid all capital letters. Writing in all caps is analogous to yelling and is considered bad etiquette.

5.2.2 Active Discussion

When engaging in active discussion with others on TCOG or TCOG-related topics via Social Media Sites, you should:

1. Disclose your relationship to our organization, and ask those you are engaging with to disclose their relationships and affiliations as well.
2. Always speak the truth. When a response or comment is requested or required, verify the relevant facts and provide references or sources of information that are current.
3. Never ask someone else to make anonymous Social Media Posts.
4. Never use your relationship to TCOG exclusively for personal gain.
5. Never use services or technologies for bulk-posting Social Media Posts. Bulk posting of comments to our blogs and social networking services is an unethical practice known as comment spam, is disrespectful of our community's attention and is strictly prohibited.

SOCIAL MEDIA USE POLICY FOR AUTHORIZED STAFF

6. Although you are discouraged from engaging directly with minors via Social Media Sites, please ensure you always use extreme care if creating content intended to be consumed by minors.
7. Always consult with a member of management before responding to any posts that may be inaccurate, accusatory or negative about Texoma Council of Governments.
8. If you are contacted directly by a known journalist or member of the news media on a Social Media Site regarding issues of concern to TCOG, you must consult with a member of management before responding in order to provide an appropriate response to the inquiry.

Section 6 - Respectfulness

Always be respectful of every individual's legal right to express their opinions, whether those opinions are complimentary or critical. TCOG recognizes and appreciates the rights of individuals to free speech. "Respectfulness" means tolerance and consideration for the opinions and positions of others, whether those opinions and positions are in alignment or conflict with your own.

Whether or not you are officially authorized to speak on behalf of TCOG, you may be seen by people outside of our organization as representatives of our brand. You are encouraged to represent the core values of our organization whenever you make Social Media Posts about TCOG or TCOG-related topics.

You should always strive to add value to online conversations by advancing the dialogue in a constructive, meaningful way. By adding value, you can effectively demonstrate respectfulness to those you engage via Social Media Sites.

Harassment, threats, intimidation, ethnic slurs, personal insults, obscenity, racial or religious intolerance and any other form of behavior prohibited in the workspace is also strictly prohibited via Social Media Sites.

When discussing religion, politics or any other Controversial Issues that may provoke a charged, emotional response, always show proper consideration by demonstrating tolerance and patience and striving to show compassion for alternative points of view.


When you make Social Media Posts about topics relevant to our organization, you should always be aware that your posts are not private or temporary. Social Media Posts live online indefinitely, and you should remember that they will be visible to a broad audience and possibly even read out of context.

Section 7 - Penalties

Failure to comply with this Social Media Use Policy may result in withdrawal, without notice, of access to information and/or information resources. Also, permission to utilize Social Media Sites may be revoked.

Inappropriate use of official TCOG Social Media Sites or other violation of this Policy may be grounds for disciplinary action, up to and including termination, as well as civil or criminal penalties as provided by law.
